In Memoriam

Victoria Chiofalo

June 24, 1936 - February 9, 2023



A wonderful extended life dedicated to love for her family and for art. She was born in Bombay, India and was raised in Shanghai, China. At the age of 12 she moved to Argentina with her father and sister. While there, as a teenager she became a movie actress and was featured in several movies (Film Andes, El Mal Amor, Surcos en el Mar). In 1959 Victoria married Roberto Chiofalo, a musical director, and had four children. In 1963 the family moved from Argentina to San Francisco, California.

Victoria loved art all her life, it was her passion. She studied painting in Argentina and continued her art studies in college, in the Unites States.

She loved people and flowers. She cultivated roses and painted them; she used to say, "I do not paint roses, I make portraits of roses and people." She worked in oils, pastels, watercolors, acrylics, charcoal, and stained glass based on her own designs of floral and portraits.

Her paintings were successfully displayed in many juried exhibitions. Her professional affiliations included the National League of American Pen Women, Inc., where she was President of the Nob Hill Branch in 2000/01. She was also a member at large of the Society of Western Artists (now Society of West-Coast Artists), where she acted as Exhibit Director for several years. Other affiliations included the California Watercolor Association, where she received her signature award in 2003.

Last November, Victoria and Roberto celebrated their 63rd wedding anniversary. Victoria is pre-diseased by her daughter Laura and survived by her husband Roberto, daughters Cristina and Claudia, son Robert, her sister Helen, six grandchildren and three great grandchildren.


Rosemarie Willimann

Rosemarie Willimann has a solo show at the Mono Lake Committee Gallery in Lee Vining, Califorma. It will be showing until the end of July.








