Aina F. Clotas is a figurative oil painter who was born in Catalonia, Spain, in 1987. After attending an undergraduate filmmaking course, Aina received her BFA from the Universitat de Barcelona in 2012. To further her training, she studied traditional painting methods at the Barcelona Academy of Art, graduating in 2015. She taught at the Barcelona Academy of Art, La Salle University and the Florence Academy of Art in Sweden.

Aina's personal work is influenced by both the nineteenth century atelier methods and the cinematography language. Her compositions are clear and striking, full of intimacy and sensitivity. Her work has been exhibited in Spain, the United States, Portugal, Canada and Estonia. Aina is living in California, where she works in her studio on personal projects as well as commissions. Abstract Botanicals in Acrylic with Texture

Yvette Head, a local artist, prefers working with acrylics and other water media to create semi abstract imagery where real objects become slightly distorted or re-imagined in new ways. For several years, Yvette followed her first passion working as an architectural designer in the Bay Area. She produced all her building plans by the lost art of hand-drafting. She created and problem-solved her designs on paper. Today, Yvette still uses some of her father's mechanical pencils and architectural scales.

Her current series of work is mostly comprised of botanical imagery inspired by the little details found in her garden or nature: the unique structure of a stem or branch bending with tiny blooms, or the shapes of flower petals as they unfold and fade. Sometimes it's the little volunteer sprouting up through the rocks and dirt that catches her eye. She has exhibited mostly in the South Bay and her work can be seen at autumnlanestudios. blogspot.com

SWA Using EntryThingy for Shows

SWA is going online for entering shows. A small committee is working out the logistics of using EntryThingy, a digital call for entries, management, and jury system.

To Start the entry process go to the SWA website: http://societyofwest-coastartists.com/swamembersshowinfo.html and under the SWA MEMBER SHOWS there is a link: https://www.entrythingy.com/d=societyofwest-coastartists.com that is for SWA members only. In the future, it could be offered to artists at large, as a member recruitment tool. You will be asked to create an identity (username and password). You may notice that the SWA call for art is not on the ENTRYTHINGY website Artists call list at Entrythingy.com, only on the website featured on the SWA website.

- Login to SWA and select SWA MEMBERS show info. The Entrythingy website is in red.
- Select the link for the upcoming show and follow the directions for entering the show.
- You will be required to have photographed your work so you can upload it to your entry page.
- Fill in the additional information pertaining to your entry.
- Pay your fee through Paypal via the Paypal button which allows you to use another credit card as well.
- Please note: SWA is charged \$2 per painting entered. With entry fees being paid by paypal or credit card, there is an additional cost to SWA. Because of this, entry fees will be \$20 for one painting and \$15 for each additional painting for regular shows.

The jury process for the show will be online and will follow the same guidelines as the in-person jury system. You will be accepted or not accepted and will be notified by email. You need to check your email, including junk/spam, no later than the Friday before delivery day. The artists will bring their accepted work to the gallery on the date for delivery or the Friday just before. PLEASE have your name and painting title on the back of your painting. The same judges who juried the show online will do the awarding (the 1st, 2nd etc). When you drop off your work it will be checked over to meet the usual criteria, you will be asked to gallery sit and we will hang your work.

If you have any problems with your entry you can contact Yvonne or Carrie and they will advise you of a day they will be at SWA gallery to help you or can be available by phone or email as well.

We have tested the system. Using the April Exhibit, with more participants, we will make a final decision before the SWA Annual, depending on the advantages or disadvantages and, of course, your feedback. Comments to yvonne.newhouse@icloud.com or ccdrilling@hotmail.com.

From 280: take the San Bruno Exit east (towards the Airport). At San Mateo Avenue (approximately 1/4 mile) turn right on San Mateo Avenue






