Remembering Dean Dallin

It is with profound sorrow, we announce the passing of our dearly loved friend and mentor, Dean Dallin. Dean passed on Wednesday, March 20, 2024. To those of us of the Society of West-Coast Artists (SWA) he was a legendary Spirit. His joyous life and dedication to the Arts will serve as an example of a creative life that enriched the lives of those around him.

Dean Dallin attended art school at the Portland Academy of Art in Oregon and Jepson Art Institute in California. He practiced commercial art for thirty years in Portland, Los Angeles, and Fresno. He spent the last twenty years seriously studying art, with nationally and internationally known artists. Dean taught beginning and advanced art privately, and conducted many art demonstrations and workshops, as well as judging art shows throughout the San Joaquin Valley.



Dean, with the help of his wife, Ruth, led an organization of San Joaquin Valley artists which became the Society of West-Coast Artist (SWA). Through his leadership and that of SWA members, the organization began art shows that involved artists from throughout California. The organization prepared the next generation of artists developing their art skills and fellowship. We will remember Dean with warm thoughts and wonderful memories.



SWA SIGNATURE AWARD SCHEDULE

Any member in good standing who has complied with the rules concerning the SWA Signature Award as set forth in the SWA By-Laws shall have the right to use the letters "SWA" in conjunction with his or her name and shall receive a certificate signed by the SWA President. Use of said letters without this certificate is prohibited.

150 Points total, must include acceptance into: 2 SWA San Francisco Annual Major Exhibits

5 points for acceptance in a show

6 points for Honorable Mention Award (which includes the 5 points for acceptance)

8 points for 3rd place Award (which includes the 5 points for acceptance)

10 points for 2nd Place Award (which includes the 5 points for acceptance)

12 points for 1st Place Award (which includes the 5 points for acceptance)

15 points for Best of Show in reg. show (which includes the 5 points for acceptance)

MAJOR EXHIBITS:

Acceptance in a show gives the artist 5 points. If more than one painting was accepted for the exhibit, the artist will still count only 5 points for each show. If an Award is given for one painting, the total points for the award are counted as indicated above.

SWA Signature Award Points are given *only* for SWA Juried Shows.

Completed application, along with PHOTO COPIES OF RECEIPTS, should be mailed to the Chapter President. The Signature Award Chairperson will verify the application correctness, then it will be presented at the next Board Meeting for approval.










